

LOULOU B bore in at the start, remained along the rail, chased the pace, found ample room inside WILLOWY through the stretch, bid for the lead in mid stretch and prevailed in a hard drive. IDES OF DEMARCH, a forward factor in the three path between horses on the turn, chased the leader and rallied. WILLOWY sped to the front, was kept well off the inner rail and weakened late. CLASSIC TIRAMISU, forced in by the winner leaving the starting gate, swung four wide leaving the turn and rallied. A BETTER WORLD, four deep on the turn, gave way and drifted in in upper stretch.
