TWIRLING WIND sped clear early, set a rated pace about two wide, met a bid from SUDDEN BRILLIANCE nearing the lane, dueled briefly, shook clear back clear under a drive in mid stretch then was fully extended to gain the narrowest of decisions. SUDDEN BRILLIANCE, four wide early, moved up into the turn, bid outside the winner past the three eighths, dueled into the lane, had the winner get away a bit leaving the three sixteenths, kept up game chase, came back through the final seventy yards and just missed in a sharp debut. BETHABARA, taken to rate outside a rival, shifted out in upper stretch and closed willingly between rivals. SUPER DONNA G, a bit fractious behind the gate, saved ground off the pace, steadied back off of a rival mid turn, regrouped and angled out entering the lane, straightened and closed well. QUIET IMAGINATION drafted off the pace, raced four wide into the lane and closed steadily. WE MISS SUSIE saved ground, eased out advancing in upper stretch, chased past mid stretch but failed to seriously sustain. MAYAS MIRACLE had speed towards the rail, steadied off the winner nearing the turn, came back along the rail mid turn, had aim into the stretch but faded. AMARIN prompted the two to three wide outside a rival, raced between foes in mid stretch and faded. LADY FIRE broke slowly, raced two to three wide in

upper stretch and lacked a rally. R V TREASURE, off slowly, was under pressure into the lane but failed to muster up a rally.
