MIXTECA vied outside CAPELINE early, took over around the far turn, edged clear through mid stretch and responded well to preserve the decision. TRULY advanced from midpack approaching the stretch in the two-path, moved out for the drive and was closing in late outside the winner. RASPBERRY BALLET was devoid of early speed, saved ground on the far turn, moved around a tiring CAPELINE finding her best stride through the furlong grounds, and finished with good energy on the fence. NOBLE MARIA saved ground in easy striking range early, shifted out three wide to loom a threat past the quarter-pole, had aim outside the leader through the lane but flattened out late. FUNNY FEATHER was in a bit tight going to the first turn, spent considerable time in the two-path and turned in an even effort without threatening. BIT COIN QUEEN bumped lightly with TINY TURBO at the start, took the first turn in the four-path, moved in after that and lacked a rally. CAPELINE vied inside the winner for six furlongs, and gave way on the rail through the stretch. BETTIN ONNA KITTEN bobbed slightly at the start, steadied to the first turn three wide, and was empty on the rail in the stretch. MATCHA tracked outside the leaders three wide, and tired after six furlongs. WICKET HOPE was in a bit tight to the first turn three wide, had the rider drop the whip near the

three-eighths, and dropped far back. TINY TURBO bumped lightly with BIT COIN QUEEN at the start, was strung out widest in the five-path to the backstretch, and dropped far back before reaching the stretch.
