Footnotes

LUCKY NINETY NINE , rated inside horses stalking the pace around the turn, raced in the two path through the stretch, split horses in mid stretch and drew off. TRULY RED , four wide on the turn, advanced to reach contention in upper stretch and flattened out. TRAP CITY sped to the early lead, set the pace

along the rail and weakened late. SEVILLA SANGRIA , steadied in close quarters along the rail entering the turn, lacked the needed late response. CREATIVE ALIBI hugged the inner rail around the turn and failed to be menace. TENDERNESS chased the pace, was four wide turning for home and weakened. RONA , seven wide in upper stretch, was not a factor. WHY YOU SASSY floated to the six path in upper stretch and weakened. MEGALOMANIA was no factor. FREEDOM QUEEN was outrun. AWESOME PAL drifted to the eight path turning for home.
