LUCKY AT JUSTICE settled into stride a bit off the inside dropping well off the first flight racing through the backstretch, gradually gathered momentum while angling out four wide entering the lane, then continued with a steady late response to wrest the advantage and go clear late under firm handling. DEVIL'S ROSE settled last racing through the backstretch while angling inwards, shifted outside foes entering the stretch and found her best stride late to prove best of the others. VEGAN GOES BEST, urged three deep between foes prompting the pace, edged clear racing into upper stretch but was collared in late stages. BRECHIN'S COMMAND tracked just off the first flight four wide between foes in early stages, was prompted to challenge three deep nearing upper stretch but flattened out in the drive. KIPPER DOODLE, forwardly placed along the rail, prompted the pace into the lane and faded late. MORA VALLEY vied for command between foes into the turn and gave way after a half. LEISHLANICK tracked off the first flight five wide racing to the turn and faded early. CONSTANCIA, caught six wide in early stages, soon dropped out.
