LIL B QUICK was rated off the first flight between foes in the opening quarter, shifted out nearing upper stretch drawing into striking distance, advanced four wide between foes to challenge for command inside the leader and edged forward late under firm encouragement. KIPPER DOODLE switched outside the first flight racing through the backstretch to advance four wide into the turn, swung five wide entering the lane while moving to challenge for command, then drifted out into the path of VEGAN GOES BEST through the final furlong while failing to contain the winner. VEGAN GOES BEST tracked just outside the second flight in the opening stages, was fanned six wide racing into the lane while advancing to challenge, lost some momentum when being carried wide in the last furlong and finished in hand nearing the wire. DEAUVILLE MIST, bothered at the start, was righted, then angled to the inside steadily gaining position inside foes racing into the turn, shifted four wide in upper stretch and continued to gain position between foes to the end. KALISPELL tracked just off the first flight along the inside, shifted out to split foes racing into the lane but had no final kick. DANCE broke outwards bumping R MARIE, ducked inwards into the path of DEAUVILLE MIST, was settled off the second flight racing to the turn and lacked a rally. AMERICAN BIZ, outpaced in early stages, passed inside tiring rivals racing into the lane. MY WIFE IS BOSS was urged between foes pressing the pace from the outset into the turn, gave way into upper stretch. MORA VALLEY, urged inside foes disputing the pace through the backstretch into the turn, gave way in upper stretch. KLONDIKE ANNIE was settled outside foes, then fanned into the wide lane but proved no threat. HAL'S MISCHIEF dropped out early. R MARIE, bumped at the start, was urged three wide forcing the pace into the turn but was through after a half. FOLLOWING THE RACE THE RIDER OF VEGAN GOES BEST LODGED A CLAIM OF FOUL AGAINST THE RIDER OF KIPPER DOODLE ALLEGING INTERFERENCE IN THE STRETCH BUT THAT CLAIM WAS DISALLOWED.
