DIXIELAND DREAM prominent from the start outside, shook clear midway in the turn while still in hand, roused past the furlong marker, slowly increased advantage to the wire under a steady right hand stick. LIL RESPECT settled behind the pace along the inside, crept a bit closer while continuing to save ground through the turn, could do little with the winner in lacking a closing punch, clear for the place. CRESCENDO BLING within striking distance early while outside, three wide when moving a bit closer late in the turn, chased the winner upper stretch, drifted out a bit then flattened out. SOUPER CAPACITY away in good order, forwardly placed inside, two path into the turn, steered out three wide for the drive, went evenly to the wire. FLAMING void of early foot, lacked a closing response. LAKE SENSE raced back early off the inside, fanned five wide into the lane, made little impact down the lane to finish up evenly. WILD ESCAPE was never dangerous while racing three wide. DANZIG STAR in mid pack early, four wide turning for home, had little for the drive. DEDE'S

TRICK failed to menace while racing four wide. MYSTICAL MATILDA broke sharp, narrowly showed the way early, dueled with the winner entering the turn, fell back off that one midway on the bend then gave way in the drive. SAILAWAY AND HIDE off a step slow, remained back throughout to be always outrun. KLASSY POINT raced toward the front in the second group three wide up the backstretch, stopped in the turn to finish far back.
