## Footnotes

BAY OF ANGELS was slow early, stayed along the rail around the turn, angled sharply to the outside in early stretch, finished full of run and was up in time. SERENE WARRIOR began a run between rivals on the backstretch, rallied to the front along the rail leaving the furlong grounds, drew clear in midstretch but couldn't last. BUTTON CANDY steadied along the inside entering the turn, came out between rivals to loom boldly into the final furlong but hung. STANCHION wasn't far back between rivals early, raced three wide around the turn and lacked a rally. FROST WARRIOR threw the rider when rank before loading, pressed the pace two wide into the stretch, gave her best between rivals into the final furlong then flattened out. FARMAVET raced four wide around the turn and had no closing. STEPITUPSTEPHANIE wasn't far back between rivals early, raced two wide around the turn and tired. BONITA LASSIE stayed inside and failed to menace. SECRETIVE REVENGE opened a clear lead along the rail soon after the break, ran out entering the stretch and faded from between rivals. CYBERSPACE was outrun.
