## Footnotes

BELLA FIGURA (IRE) was rated attending a rival's pace racing to the backstretch, took over on the far turn, then kicked away through the stretch to prove best under firm left handed encouragement. ACCORDING TO ASPEN tracked the leaders outside a rival as part of the second flight racing to the far turn, shifted out three wide racing through the stretch and edged rivals for the place honors late. LULUMARU sped to the lead along the inside racing to the first turn, dueled for command inside the eventual winner into the far turn and weakened in the drive while finishing on even terms with a rival for a share. FRIENDLY AND KIND threw her head at the start, was righted, then angled to the rail tracking just off the leaders to the far turn, tipped out in upper stretch and continued with a mild bid while finishing on even terms with a rival for a share. DEPUTY DORA, reserved between foes off the second flight racing to the backstretch, swung out four wide racing into upper stretch but made no impression. GIVEITSOMEWELLIE, reserved along the inside in the last flight while pulling against restraint racing to the backstretch, never gained contention. SUNDEREYA settled three deep in the last flight racing to the backstretch and retreated early.
