CLOSE TO ME last to leave, behind the pace off the inside, ranged up to challenge three wide midway on the final turn, narrowly showed the way into the lane, drew clear under steady handling. SWANAGE narrowly set the early pace inside, dueled into and through the far turn, headed by the winner into the lane, held stubbornly until late, remained clear for the place. ROAD TEST lacked speed along the inside, continued to save some ground far turn, moved out a bit to race in the two path into the lane, bothered slightly by a fallen rival upper stretch, mild late interest to be up for the show. PERSISTO in the second flight outside, moved up four wide with and outside the winner midway on the final turn, battled into the stretch remaining on the outside, weakened the final furlong to lose the show. DARING fell back to trail, raced on the outside, lacked a closing response while remaining wide. DAIGLE with the early pace, fell back after a half, was going one paced in the back of the pack turning for home, jumped over fallen foe soon after, unseated rider, walked off. MOSTLY AWESOME with the pace three wide first turn, dueled into far turn, lost some position turning into the stretch, in tight, clipped heels and fell in upper stretch, walked off. FOLLOWING A STEWARDS' INQUIRY REGARDING THE INCIDENT AT THE TOP OF THE STRETCH, NO ACTION WAS TAKEN.
