RIVIERA CHAMP broke readily, sped clear of the field remaining off the rail racing to the backstretch, held sway on a commanding margin into upper stretch and was kept to task. TOP DOG, reserved along the inside in the opening half, saved ground gaining position on the far turn, then angled four wide advancing between foes into the lane to prevail for the place honors late. SHATTERED DREAMS, off slowly, was settled last to the far turn, swung out six wide racing into upper stretch and produced a solid closing effort while just outkicked for second. BEHAVIN MYSELF, urged along the inside pursuing the pacesetter from the outset to the far turn, emptied out late. CAUSEIMCHOCOLATE, off slowly, tracked the off the second flight while shifting well off the rail in the opening half, was fanned five wide racing into upper stretch but lacked the needed late response. MALIBU CHANNEL tracked off the second flight between foes in the opening half, was prompted to split rivals just off the inside nearing upper stretch but had no final kick. SHINBORO, forwardly placed three wide tracking just off the pacesetter to the far turn, faded between foes nearing upper stretch, then steadied avoiding tight quarters racing past the three sixteenths marker losing all momentum. BOOTLEGGIN POSSE, reluctant to load, broke inwards bumping THIRSTY KISS at the start, was prompted to contention racing in the five path through the first turn, continued with interest four wide into the second bend and gave way after six furlongs. THIRSTY KISS, bumped at the start, dropped out early.
