WICKED PRANKSTER sprinted clear soon after the start, was taken to the inner rail approaching the first turn, remained along the rail throughout, responded tenaciously n the drive and prevailed. STREET COPPER raced in mid pack down the backstretch, moved up outside foes on the far turn, was fanned five wide at the head of the stretch and rallied. CRABS N BEER, three wide both turns, chased the winner throughout in a game performance. JOHNG lacked speed, swung to the six path in upper stretch and rallied outside foes. MIDNIGHT HAULER, in the three path on the first turn, was in the four path between horses turning for home and passed tired ones. NICK PAPAGIORGIO, reluctant to load into the starting gate, prompted the pace outside the winner and weakened late. CANNON'S ROAR, checked in tight quarters approaching the first turn, circled the first turn four wide, remained well off the rail and failed to rally. RHUMJAR, steadied in close quarters approaching the first turn, hugged the inner rail entering the stretch and lacked a rally. SO STREET stalked the pace racing along the inner rail and weakened in the drive. NICKY BEAR, along the inner rail on the far turn, was not a factor. BENNY HAVENS, well placed four wide entering the stretch, faltered. MR. D'ANGELO was outun. UP AGAINST IT, three wide the first turn, was five wide leaving
