KATIES A LADY was sent to an early lead the first time by, opened up while saving ground around the first turn and up the backstretch, continued to save ground around the turn and remained in command to the wire. INANNA'S QUEST raced at the back of the pack on the outside through the opening half mile, began to improve position from the three path coming around the far turn and continued to gain ground in the lane while proving to be no match for the winner. PUGILIST raced off the pace on the outside around the first turn and up the backstretch, navigated the far turn still in the two path and gained ground late. SLIME QUEEN saved ground around the first turn, chased the leader well off the pace up the backstretch, continued to save ground around the second bend and weakened in late stretch. FALL MOON raced in the two path around the first turn, continued up the backstretch at the back of the pack on the inside, navigated the far turn from the four path and improved position mildly in the lane while never threatening. LULLABY LAND saved ground early, settled in the middle of the pack between horses for the run up the backstretch, raced in the three path around the second bend and finished evenly. IRAZU raced off the pace on the inside through the opening half mile, continued to save ground around the far turn and offered no bid. STARRY HOPE raced in the three path around the first bend, continued up the backstretch off the pace on the outside, navigated the far turn from the five path and was empty in the stretch. CHICK'S SHADOW raced in the two path in the early going, came up the backstretch in the middle of the pack on the outside, continued around the

far bend in the four path and tired in the lane. LIZZ A BEE trailed the field on the inside around the first turn and up the backstretch, raced in the three path around the far turn and never factored.
