Footnotes

JUSTICE OR APPEAL set the early pace on the inside, drew clear leaving the turn and then held sway late to prove best, driving. DESI'S REWARD tracked the early pace, was three wide on the turn and angled out when straightened off the turn, closed well but too late, second best. FOREVER FIFI was reserved early, wide on the urn and came widest into the lane and had a late rally to gain the show award. OBER DARE stalked the winner and made a three wide bid on the turn but could not sustain that bid, lost the show award. NANASQUAN was settled early, came four wide into the lane and had a belated rally. LITTLEMISSKNOCKOUT passed the tiring rivals. TRAJEC HOLIDAY chased the early pace, four wide by the quarter pole and weakened. MISS MIA LIA was settled back early, inside by the quarter pole and had no response. LITTLE MOOJI chased the early pace and weakened. WICKED RED was off very slowly, then made a wide run and stopped on the turn.
