ONEOFTHEGOODGUYS showed good early foot from the outside racing two deep and drew off to be well clear under strong pressure. BEAR OR BULL raced mid pack early on, made a four wide bid near the three eighths pole and got up for the place position. BEJUCO vied for the early lead from the inside and weakened a bit the final eighth of a mile. BOOK RUNNER was void of early speed, raced from the outside in the stretch and moved up to improve position. HARVEY SPECTER hesitated at the break, raced three to four wide in the lane and had no rally. SNIP THE ROSES broke awkwardly, raced along the inside around the far turn through the upper stretch and never threatened. TUNA N STAMPS coaxed along early, raced between nearing the three eighths pole, checked sharply and faded thereafter. Jockey of Tuna N Stamps claimed objection for interference and stewards ruled no change.
