## **Footnotes**

JUMP FOR THE WIN set the pace on the inside, then was pressured on the backstretch, dueled by the quarter pole with THUNDERLAN, then had a long drive with that rival, came out slightly under left hand crop and exchanged bumps but held on determinedly to prove best. THUNDERIAN stalked the early pace three wide, then made a bid to duel with the winner two wide on the far turn, then exchanged bumps through the stretch drive but hung late. STEADY JOHN had an awkward break, settled early, advanced on the inside on the far turn, then made a inside bid in the lane but needed more late. GOOSE HUNTER chased the early pace four wide, shifted in to the inside at the nine sixteenths, then dropped back on the inside, then made a inside move nearing the quarter pole and had some late kick. CAJUN OCCASION tracked the pace three to four wide and weakened in the lane. The rider on number two THUNDERLAN filed an OBJECTION against the winner for interference in the stretch, after the STEWARDS reviewed the video replays the OBJECTION was not allowed and the race was left as is.
