MAGGIE'S GIRL bore in and made contact with BARBERS POINT leaving the gate, took a quick lead and moved to the inside to rate the pace, was urged away at the rail on the far turn then kept alert in the lane. The latter was bumped leaving the gate then stalked off the rail, gave chase approaching the three eighths pole, rounded the far turn off the rail and dueled clear for second later yards. NO DENYING DENIS was forced out leaving the gate then settled off the rail, picked up the chase nearing the three eighths pole, raced off the rail on the far turn and relented in the stretch duel for second. TIMETOGETUP rated close inside, gave chase nearing the three eighths pole, rounded the far turn at the rail and weakened in the lane. AIM'S JUBILEE was jostled leaving the gate, raced in the four path the first turn, gave chase from the seven sixteenths pole but weakened into the far turn. WHATTA NOTION ducked out and steadied leaving the gate, raced in the five path the first turn, gave chase from the three eighths pole, rounded the far turn about the four path and weakened in the lane.
