SUSAN'S MULE broke a step slow, quickly recovered and accelerated to a staking spot three wide, bid to engage the duelers three deep past the five sixteenths, secured command soon into the lane, opened up under a drive and was kept alert to deep stretch. DETERMINED BLUE had speed then chased while in the clear mid turn, shifted out in the drive and continued on willingly to earn the place. IRISH RAGE , off the pace, moved up between rivals leaving the far turn, angled out a bit to go three wide between runners in upper stretch, shifted further out for the final furlong and rallied. NO WALK INTHE PARK broke a step slow, saved ground leaving the far turn, angled seven wide through the drive and finished with interest. SUNNY SUNSHINE was sent up between rivals to take over early, secured the rail and set a pressured pace, stayed on willingly to mid stretch then faded. KAPADOKYA , away alertly, disputed the pace outside SUNNY SUNSHINE, fought between rivals into the lane then faded through the final furlong. PASS THE CASH flashed speed,
chased the leaders off the rail, came three to four wide for the drive and gave way. NEXT GIRL shied inward and retreated near the half, regrouped around the turn, came three to four wide into the lane but lacked a solid finish. YUMYUM EAT EM UP bobbled at the break, raced well back while three wide, angled six wide into the lane and failed to threaten. SHARMIN stumbled badly at the break, raced far back into and around the turn, came wide for the drive and offered a mild response. LEAVE DRAMA BEHIND flashed speed, chased while saving ground and faltered in upper stretch. SMOKIN SISTER, three wide early, angled in around the turn and dropped back through the drive
